Mr. Brennan - Is there anyone here who would like to make a comment regarding any legislation that is being acted upon today? Seeing none; we will go into Communications, Petitions, and Claims.

COMMUNICATIONS, PETITIONS, AND CLAIMS

Mr. Brennan - Related that there is great sadness in the passing of Halyna Bereza, owner of Nicky's Cafe. She was 58 years young.

Mr. Divis: Variance for Bill Gallagher. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the applicant, Bill Gallagher, the duly authorized representative of 5301 Group Partnership, LLC, 35350 Chester Rd., Avon, OH for property at 5301 Hauserman Rd. PPN 442-01-003.

The APPLICANT had requested a "Use" variance of the City of Parma Codified Ordinances, in particular, Section 1153.02- SINGLE FAMILY HOUSES DISTRICTS-PRINCIPAL USES AND BUILDINGS. The proposal is to use the old Army Reserves property presently located in Single-Family House District, for offices and trucking facility located at 5301 Hauserman Rd. Within any Single-Family House District, no building or premises shall be erected, used, arranged or designed to be used, in whole or in part, for other than single-family residences and detached dwellings. This variance would result in allowing for an office use and a trucking facility use of property located in Single-Family Zoned district.

The Zoning Board of Appeals denied this variance because the Applicant withdrew the application. Motion made by Councilman Divis, seconded by Councilman Day to deny this variance. Motion carried.

Mr. Divis: Variance for Lisha Manuel/Jeff Dubitsky. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the applicants, Lisha Manuel & Jeff Dubitsky, Pecked Over for property at 5636 Ridge Rd. PPN 443-03-012.

They have requested an "Use" variance of the City of Parma Codified Ordinances of Section 1170.03- PLANNING & ZONING CODE – SCHEDULE OF PERMITTED BUILDINGS AND USES. The proposal is for business use not permitted in Retail Business District at 5636 Ridge Rd. Building and land shall be used, and buildings shall be designed, erected, altered moved or maintained in whole or in part only for uses set forth in schedules and regulations. The Applicant is proposing to run a store selling refurbished, reconditioned collectible merchandise in Retail Business area which prohibits junk dealers, pawnbrokers and secondhand dealers. This variance would result in allowing for business use prohibited in retail Business District.

The committee agreed with the Board of Zoning Appeals that this be denied because the owner's predicament can be obviated through a different manner and the spirit and intent of the Zoning Board would be observed."

Motion made by Councilman Divis, seconded by Councilman Day to deny this variance. Motion carried.

Mr. Divis: Variance for David Buccieri. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the applicant David Buccieri for property at 7510 Snow Rd. PPN 443-05-056. The applicant has requested an "Area" variance of the City of Parma Codified Ordinances of Section 1199.07 (d) – SCREENING AND BUFFERING – BUFFER AREAS FOR YARDS ABUTTING PUBLIC STREETS AND PARKING LOTS – LENGTH OF BUFFER STRIPS. The proposal is for parking for new use as club at 7510 Snow Road. Street buffer and six foot wide perimeter parking buffer strip shall be continuous and extend along the entire length of the front lot line that abuts a public right of way except for areas pierced by walkway or driveway aisles to the extent necessary to provide safe ingress to and egress from the property. The proposed buffer is 3 feet. This variance would result in 3' less wide perimeter parking buffer strip than required by Code.

Motion made by Councilman Divis, seconded by Councilman Day to approve the variance. Motion carried.

Mr. Divis: Variance for Phillip Pavarini, Sr. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the APPLICANT Philip E. Pavarini, Sr., for property at 3401 Brookpark Rd. PPN 444-04-008.

The applicant has requested an "Area" variance of the City of Parma Codified Ordinances of Section 1197.05 (32) & (33) – OFF STREET PARKING AND LOADING FACILITIES – SCHEDULE OF REQUIRED PARKING – AUTO BUSINESS – SALES AND SERVICE. The proposal is to open Rental Car establishment at 3401 Brookpark Rd. Minimum of 15 parking spaces required for motor vehicle sales and service establishment. The proposal is for 6 spaces. This variance would result in 9 less parking spaces than Code requires.

Motion made by Councilman Divis, seconded by Councilman Day to approve the variance. Motion carried.

Mr. Divis: Variance for John LaRussa. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the APPLICANT John LaRussa for property at 7612 Dartworth. PPN 449-05-100.

The applicant has requested an "Area" variance of the City of Parma Codified Ordinances of Section 1153.03 (a) – SINGLE FAMILY HOUSE DISTRICTS – ACCESSORY USES AND BUILDINGS. The proposal is to build new garage larger than Code allows at 7612 Dartworth. Maximum size of garage permitted on lot size 40' x 140' (5,600 sq. ft.) is 566 sq. ft. The proposed new garage size is 704 sq. ft. This variance would result in allowing new garage size 138 more sq. ft. of area than allowed by Code for detached garage on lot size of 5,600 sq. ft. The stipulations are that the drawings that were submitted to the Building Department be corrected, the shed is allowed to remain for up to a month after the final approval on the new garage.

Motion made by Councilman Divis, seconded by Councilman Day to approve the variance with stipulations. Motion carried.

Mr. Divis: Variance for R.J Mascia Corp. The Planning Committee of Council met on June 9, 2014, to discuss the variance for the APPLICANT R. J. Mascia Corp., for property located at 6207 Renwood Dr. PPN 448-13-081.

The applicant has requested an "Area" variance of the City of Parma Codified Ordinances of Section 1153.03 (a) – SINGLE-FAMILY HOUSE DISTRICTS – ACCESSORY USES AND BUILDINGS. The proposal is to build new garage larger than Code allows at 6207 Renwood Drive. Maximum size of garage permitted on lot size of 40' x 129' (5, 160 sq. ft.) is 516 sq. ft. The proposed garage addition to existing 504 sq. ft. garage is 210 sq. ft. for total area of 714 sq. ft. This variance would result in allowing 198 more sq. ft. of area for detached garage on lot size of 5,160 sq. ft.
