A 20' rear setback to the adjacent residential district is required per the schedule of yard and height requirements. The proposal is a 4' 7" rear setback from residential district. This variance would result in 15'5" less rear setback from residential district.

The request is for an "Area" variance of <u>Section 1153.03(b)(2) – SINGLE-FAMILY HOUSE DISTRICTS-ACCESSORY USES AND BUILDINGS REGULATIONS-OVERNIGHT PARKING OF COMMERCIAL VEHICLES.</u> The proposal is parking of dual wheels over 82" in height exceeding a gross weight of 8,500 pounds on lot in Single-Family House District at 7791 Lime Lane. There shall be no overnight parking of vehicles exceeding a gross weight of 8,500 pounds or an overall height of 82". This variance would result in allowing to park commercial vehicle on lot in Single-Family House District.

The proposal is to rebuild, for property located at 2114 North Avenue, a current legal non-conforming two-family dwelling in a Single-Family District should the dwelling be destroyed in the future. Within any Single-Family House District, no building or premises shall be erected, used, arranged or designed to be used, in whole or in part, for other than single-family detached dwellings. A legal, non-conforming two-family dwelling in a single-family house district which would require variance to allow rebuilding of two-family structure if destroyed. This variance would result in allowing for rebuilding of two-family dwelling in a Single-Family House District.

Human Resources Director Weinreich stated that this test was scheduled because there are two openings in the police records room with a third opening occurring due to a pending retirement.

Mayor DeGeeter stated that Chief Miller has asked for more records clerks and he has been denied in the past. They are down two clerks and the department is behind in their reports.

Councilwoman Lime asked if there will be any hiring before the end of the year.

Mayor DeGeeter said candidates still have to go through the process and testing. The Chief Records Clerk is retiring at the end of the year.

Councilwoman Lime asked if hiring will occur by year's end.

Mayor DeGeeter said the Safety Director may know more.

Safety Director O'Malley stated that this is a long process but the dilemma is that the primary duty of the Records Clerk is to input data into the system and this is affecting ticket processing time. Compiling of reports that are required by the State of Ohio regarding crime statistics are also being affected due to less personnel. Pat Phillips is retiring at the end of the year and one of the existing Clerks will resume the lead duty. Testing will occur amongst the current clerks. Police Chief said this is beginning to cause delays in day to day operations with less clerks.

Councilwoman Lime asked how may clerks are in this position currently?

Safety Director O'Malley said he believes there are 5 and now down to 3 and that will come down to 2 with the pending retirement.
