*Divis – My vote will be "No" with comment: I want to express my appreciation to the Administration and to the Auditors office for their hard work in preparing the Budget. The main reason I find myself unable to support this Budget is because I believe we need to devote more resources to streets and street repairs. I do not want to speak for my colleagues, but the Number one issue facing our city is the condition of the roads. I hear this almost every day from Ward 5 residents. I will tell you

that I think Service Director Brian Higgins is like MacGyver using "paper clips and rubber bands" to keep the streets going as best he can. He does a great job with the resources we have but, unfortunately, we need more help. Our residents are demanding it. If we want our city to remain vibrant and to keep our residents and businesses in town, we need to do more. I would ask the Administration to consider a streets levy. I checked with the City Auditor's office and learned that we could raise approximately \$2,188,732.00 million per year with a 1.5 mil levy which would cost the taxpayers \$53.00 per year on a typical \$100,000 Parma home. The levy would last 5 years and in that time frame we would raise \$10,943,660.00 to be used exclusively for streets. And it would be renewable! With a plan like this we can start to catch up on needed repairs. Thank you.
