## **COMMUNICATIONS, PETITIONS AND CLAIMS**

Councilman Divis - Stated that the Planning Committee of Council met this evening, to discuss the Notice of Proposal to Vary for the Applicant Anthony R. Vacanti, Esq. of Buckingham, Doolittle & Burroughs, LLC, 1375 E. 9th St., Ste 1700, Cleveland,

OH 44114 representing Bola Morgan, Morgan's Towing & Auto Service, 5701 Pearl Rd., Parma 44129. PPN 443-04-012.

The request is for a "Use" variance of the City of Parma Codified Ordinances of Section 1170.03 – COMMERCIAL/OFFICE DISTRICTS – SCHEDULE OF PERMITTED BUILDINGS AND USES. The sale of used products is not included in permitted buildings and uses in the Retail Business District. Permitted only in Commercial Manufacturing A & B Districts. The proposal is for property located at 5701 Pearl Rd to use existing building in Retail Business District for sale of used tires. This variance would result allowing the use of building in Retail Business District for sale of used tires. The stipulations are:

- 1. All business operations shall conform to Parma's Ordinances, including but not limited to, the performance standards set forth in section 1170.15 of the Parma Codified Ordinances.
- 2. Tire racks may be displayed outside of the building between the hours of 9 A.M. and 6 P.M. All tires and racks shall be stored within the enclosed building at all other times.
- 3. No business operations shall be conducted on any street or other public right-ofway.
- 4. All signage shall conform to Parma's Ordinances. Signs that are not permitted under Parma's Ordinances must be removed.
- 5. All Building, Zoning and Property Maintenance regulations must be met 30 days from date approval by Parma City Council, unless additional time is required due to weather or other circumstances outside the reasonable control of the applicant, in which case an additional reasonable time not to extend past June 1, 2018 will be granted.
- 6. No vehicle may be used for storage.
- 7. All vehicles must be licensed and plated.
- 8. Any and all parking on side street (Dresden) shall comply with all parking regulations set forth in the Parma Codified Ordinances.
- 9. No parking on sidewalk.
- 10. Clean sidewalk of oil.
- 11. No abutting property shall be used to conduct any business operations, for the disposal of waste products, or for storage of any sort.
- 12. No car sales anywhere on property.
- 13. Sidewalks must be cleared of snow.
- 14. Violation of any stipulation set herein shall result in the revocation of the use variance.

Discussion took place between Council, Attorney for Applicant and Law Director regarding whether or not the applicant was going to withdraw his application for the variance due to him only having 30 minutes to work on his work vehicle. It was decided not to withdraw.
