Mr. Brennan – Questioned why this was on suspension without any discussion. Service Director Higgins – Stated it really didn't need to be on suspension. Since Parma no longer has the water lines (Cleveland Water agreement), the funds no longer can go to the water lines.

Mr. Brennan – Stated when it was voted on years ago, a percentage went towards water lines, sanitary and storm lines.

Service Director Higgins - Stated moving the percentages into Sanitary and storm. Councilwoman Lime – Stated she understands, we don't have the water fund any longer. The 70% into Sanitary and 30% into Storm. Is the 70% going towards the cost of streets you have been repaying this year?

Service Director Higgins – Stated the bulk of the money goes on everyday expenditures to Sanitary, it is the same amount of money on all Sanitary items.

Councilwoman Lime – Questioned if this was money that the County was holding or is it in City funds?

Service Director Higgins – Stated all part of \$2.59 per front footage on Public Works. Councilwoman Lime - Questioned Why 70% to Sanitary and only 30% to Storm?

Service Director Higgins – Stated most of the money is spent on the Sanitary side of it and have the money for the storm and can use the Community Cost Share Money (MCI) to make repairs.

Mr. Brennan – Stated we are not in the book for any more waterline repairs in Parma. Motion made by Councilwoman Lime seconded by Councilman Casselberry to adopt Ordinance No. 191-19.
