Mr. Kulchytsky – Stated that this is something the Auditors brought to our attention. We have been working on this for the past year. These two checks from 2013 were two checks that were created by someone else and cashed. We were working with Huntington Bank to get the money back, but they are unwilling to reimburse the Public Housing Agency.

Councilwoman Lime – Asked if they contacted the State of Ohio and attempted to get their state income check.

Mr. Kulchytsky – Stated that someone actually created their own checks and ran them through our accounts, which caused us to close our accounts and open new ones. They have been on the books for a year and a half we have just been waiting for closure and a response from the Auditors on how to handle this.

Mr. Brennan - Stated, I take it that this is a case of fraud.

Mr. Kulchytsky – Correct.

Councilwoman Lime - Asked why were they not prosecuted?

Mr. Kulchytsky – Stated that there was no one to prosecute. All we knew was that the individuals went to Walmart. Huntington Security was involved trying to locate the individuals and nothing ever cam of it.

Mr. Brennan – Asked if the Parma Police Department was involved.

Mr. Kulchytsky – Stated that he would check into that.

Mr. Mastroianni – Stated we did receive notification from Huntington in regards to these checks I know that the Police Department was involved they are reviewing the tapes. They also tried to cash some checks in Columbus too. Huntington actually is doing a great job on this, they actually printed their own checks

Mr. Dobeck – Stated this is a house keeping accounting measure to clear it from their books. If the money is found there will be restitution and put on the books that the money was returned. This does not stop the Police from prosecuting this case.

Mr. Brennan - Asked is Public Housing actually suffer the lose?

Mr. Kulchytsky – Yes, it was us that suffered the lose.
