The Parma Board of Zoning Appeals met on Tuesday, May 11, 2021 and PROPOSED TO "VARY, subject to the provisions of amended Ordinance 1127.13 (confirmation or rejection by Council within forty days of the receipt of this notice) FOR THE APPLICANTS Amanda Jenkins and Matthew White, 3801 Stary Dr. PPN 453-05-023. After discussion Mr. Mastrobuono made the following recommendation: "I recommend to Council with a stipulation to GRANT Amanda Jenkins & Matthew White, 3801 Stary Drive, 44134 have requested an "Area" variance of the City of Parma Codified Ordinances of Section 1707.09 – EXTERIOR PROPERTY AREAS. (a) No owner or operator of any premises shall maintain or permit to be maintained at or on the exterior property areas of such premises, any condition which deteriorates or debases the appearance of the neighborhood, reduces property values in the neighborhood, adversely alters the appearance and general character of the neighborhood. The proposal is for front yard

parking pad out of character with the neighborhood in front setback of corner lot on property located at 3801 Stary Drive. This variance would result in allowing parking pad in front yard of a corner lot. The PPN 453-05-023. The essential character of the neighborhood would not be substantially altered and the adjoining properties would not suffer a substantial detriment as a result of granting this variance. The stipulation is that pine trees will be planted and they be a minimum of 5' in height and planted within 2 weeks of the parking pad installation. If any of the pines die, they be replaced."

Mr. Ziefle second the motion. Mrs. Green, Mr. Yurkiw, Mr. Mastrobuono, Mr. Ziefle and Mr. O'Connor voted to recommend to grant this variance. Also be it noted that a variance once granted, shall not be withdrawn or changed unless there is a change of circumstances or if after the expiration of six months no substantial construction is done in accordance with the terms and condition for which such variance was granted. In which case the Building Commissioner shall give notice in writing, and thirty days thereafter the variances will be deemed null and void, and all regulations governing such premises in question shall revert back to those in effect before the variance was granted.

After discussion Mr. Ziefle made the following recommendation: "I recommend to Council to GRANT to The Great Garage Co., John D'Amico, 1309 Ridge Rd., Suite #2, Hinkley, OH. 44233 has requested an "Area" variance of the City of Parma Codified Ordinances of Section 1193.01 - RESIDENCE DISTRICTS; SPACE BETWEEN BUILDINGS. The proposal is to build an attached garage closer to the property line than Code allows on property located at 8202 Chesterfield Ave. for homeowners Jason & Holly Kowallek. In a residence district, each main building shall have a yard along each side lot line. The sum of the widths of the side yards of an interior lot in a residence district shall be no less than 10 feet at any point. The proposed side yard widths total 6 feet. This variance would result in allowing for side yard widths totaling 4 feet less than Code allows. The PPN is 442-19-020. By granting this variance the characteristics of the neighborhood would not be substantially altered and by granting this variance the spirit and intent of the zoning and building requirements would be observed."

Mr. Yurkiw second the motion. Mrs. Green, Mr. Yurkiw, Mr. Mastrobuono, Mr. Ziefle and Mr. O'Connor voted yes. Variance recommended to be granted.

The Applicant is proposing to build new detached garage with height of 17 feet, $10 \frac{1}{2}$ " on parcel of 4,800 sq. ft. on property located at 2901 North Ave. This variance would result in allowing for 2 feet, $10 \frac{1}{2}$ inches more in height than Code allows. The PPN 444-06119. By this variance being granted would not affect the character of the neighborhood and it would not be substantially altered."

The amount of hard surface area for a driveway in residential front setback shall not exceed 32% of front setback area and width shall not exceed 16 feet wide on lot with 57 feet effective frontage. This variance would result in allowing 8 feet more than Code allows of driveway width. The PPN is 454-01-026. By granting this variance the characteristic of the neighborhood would not be substantially altered and by granting this variance the spirit and intent of the zoning and building requirements would be observed."
