PUBLIC SESSION

Pat Lovejoy, President of Parma Professional Firefighters Local 639 — Informational discussion regarding relationship between the City and Labor Management. Concerned about budget cuts. Parma is not a small town. No comparison with other cities and how they operate. Safety forces responsible for over 80,000 residents. In 2009 during recession, 100 firemen worked 4 days (24 hours each day) for free. Minimum staffing was reduced to 21. Current request is to reduce minimum staffing to 21 again. We cannot do the same job we were hired to do with longer response times. We need to keep our staffing levels safe as well. Looking for solutions on budget cuts. November 1 received a letter requesting staffing reduction to 21. How can we avert going down to 21? Fire department has brought in more than 2 Million Dollars in grants since 2009 another \$300,000 from 2003-2009.

Ken Ehlert – Please keep the Fire Department staffing levels where they are.
