DISPOSAL OF JOURNAL

COMMUNICATIONS, PETITIONS AND CLAIMS

Chairman Divis - The Planning Committee of Council met on September 18, 2017, to discuss the variance for the applicant, Ted Macosko of T.S. Macosko Architects, Inc., for the property at 5341 Pearl Road, 44129. The PPN is 443-23-029, 030 and 031.

He has requested an "USE" variance of the City of Parma Codified Ordinances of Section 1170.03 – COMMERCIAL/OFFICE DISTRICTS – SCHEDULE OF PERMITTED BUILDINGS AND USES. The request is to use existing building in Retail Business District for medical marijuana dispensary and processing facility located at 5341 Pearl Road. Medical marijuana facilities not included in permitted buildings and uses in Commercial/Office Districts schedule. Permitted only in Industrial A and Industrial Park Districts. This variance would result in allowing for use of building in Retail Business District for medical marijuana dispensary and processing facility. There are stipulations to granting this variance that are in reference to the Board of Zoning Appeals Engineer's comments number (6) the only process that will be approved as part of this variance would be the CO² process. By your own admission there are other processes out there that would be more detrimental and that is NOT and I repeat that is not part of this and (#7) is that there would be an agreement to be drawn up to cover any ideas or problems that the contiguous landowners would come up with through the Council; and that the fire alarm be incorporated with the security system and possibly and if the Fire Department so deems it is necessary to have the bars removed so they could go and get into the building to fight the fire properly and that the variance is recommended subject to the applicant entering into a development agreement with the City in substantially similar form as the exhibit attached hereto. The property owner's predicament cannot be obviated by any means specifically the area that they allocated throughout the City is not acceptable and violates State Code for the operation of this. With this variance being granted the characteristic of the neighborhood would not be substantially altered, with the variance being granted the intent of the Zoning and Building Code requirements would be observed. The Applicant agreed to these stipulations.
