Law Director Dobeck- Stated that as they are proceeding in the lawsuit, they are now joined as a part of. It became evident that this problem is a bigger problem than they even anticipated. Federal Judge Polster has taken on the task of all State, Local and Federal Lawsuits. They have been transferred to his docket to try and resolve it. All of the communities that have filed and joined the lawsuit, are declaring that the opioid epidemic is a nuisance. As part of that they will be collecting all materials and information concerning the losses that each city suffers. That could be what they pay for their call outs, transportation to the hospitals, etc. The attorneys were indicating that they would like to have the communities declare a nuisance and declare a state of emergency. He contacted Councilman Crossman, who had been involved in this from the beginning and asked if he would sponsor of the legislation.
