Councilman Tuma – As the Administration indicated earlier, we are asking that the developers in this instance take the steps necessary to reasonably accommodate the residents of Pine Tree Vista with respect to any safety issues. I also ask that there be a traffic survey done and that be taken into consideration as the project moves forward, and that the developers work with the Planning Commission with respect to safety concerns as they move forward as well.

Councilman Crossman – I am guessing that the character of the neighborhood has changed since Fifth Third and Dunkin Donuts were constructed. It doesn't seem like we would have much of a leg to stand on by not agreeing to rezone and would be the subject to litigation if we to deny the rezone.

Councilman Tuma – That is my understanding as well given the nature and character of the neighborhood as it stands now. This property was a church at the time and is a residential property and both to the north and south of that property are now businesses. Also, to the west of the property are businesses and I don't see any viable argument for maintaining it as a residence.

Mr. Miller – It would be a fight for us to deny the zoning. I am not saying that we wouldn't prevail, but it certainly would be fight. We had a fight, a number of years ago, when Colozza's, right in that same neighborhood, wanted to change a single-family home to a business. That was quite a fight. We prevailed on that, but this is a little different and I think it would be problematic. I would also make note that for Mr. Tuma who wants them to work with the Planning Commission to accommodate the residents and it is certainly the way it has to go. We can't, for zoning purposes, put conditions on the zoning. That can be done in a variance issue proceeding, but for zoning you are voting for the zoning or not for the zoning.

Mayor DeGeeter – Just kind of reiterate for the record everything that was spoken by the Ward Councils and the Law Director. Everything north where there is an Outback, Wendy's, Kohl's, Target, Chick fil A, the Plaza, it is all zoned commercial. This is the only parcel that is out there. Again, if you look to the south, that was Office, which was a lawsuit originally to get that zoned office, and there was no interest in that property. We will honor the Councilman's concerns regarding asking for a traffic study done at the time of Planning Commission. All members of the Planning Commission are aware. We have a wonderful Planning Commission Member, Katherine Holmeck, who is a landscape architect who does a great job on the buffering, mounding, etc. We will look to utilize her expertise as this project goes forward and will stay in constant communication with the Councilman.

This is a meth house for the second time. They also have a garage that they started to put up that is the size of a barn that they have already been convicted of in Municipal Court. We are going to go after this person with all zeal.

Auditor Day – Thank you, Councilwoman Saban, for picking up the ball over there and running with this. This was huge challenge in Ward 4 for years. Was a meth house. The individual built a huge barn/garage without permits that. We successfully had this individual remove the barn, but he kept going to the courts and they kept kicking it back to us. So, we received little help from the courts and it was quite a

challenge for years of dealing with this property. So, this has been a huge issue on Marietta and I agree with Mrs. Saban, there will probably be a party thrown over there.

AN ORDINANCE TO AMEND A PORTION OF SUBSECTION (b) OF SECTION 1705.99 "PENALTY" OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA, AND DECLARING AN EMERGENCY

Councilwoman Lime - I would ask that we put it back to Committee for discussion before passage.

Mayor DeGeeter – I will refer to Mr. Deichmann, but this is a change to add something that was inadvertently left out.

Mr. Deichmann – This is to clean up an oversight from a couple of years ago when we amended the penalty clause section 1705.99. It was passed originally. It was 1707.17 (g) which dealt with the time limits on which the garbage cans be out on the tree lawn before and after pick up. It did omit Section (b) which is the section in the code which deals with the proper storage of the cans on those days when it is not time for pick up. So, it was simply an oversight a couple of years ago.

Councilwoman Lime – This is the penalty end of it though. This is not talking about someone on the street having their trash cans out. This is actually the penalty. So, I believe that, before we pass anything with the penalty in there we should have some discussion. I just want to make sure that everyone is knowledgeable to what this actually does. It makes it a minor misdemeanor, which I believe is a ticket and sends it over to Court.

Councilman Crossman – This, to me, looks like it might have been a typo.

Mr. Deichmann – This was actually caught by the Court, but it is correct. It was a typo originally. Section (b) should have been in there at the time this was originally amended. It could complicate enforcement if it is not added.

Councilman Crossman – In essence, Council already approved this, but there was just an omission when the original legislation was proposed to Council. It is a reference to a section. Correct?

Mr. Deichmann – That is correct. It was originally a typo when this was originally put together and we are just simply bringing it up to where it should have been when this amendment to the penalty sections were originally passed.

Councilman Crossman - I would submit to Council then that Council, when it was passed, this was probably thoroughly discussed as to what the penalty would be and this is just clean up.

Mayor DeGeeter – I believe what happened was, one of our inspectors cited someone under that, took it to court, and found out that (b) is not within that penalty for a minor misdemeanor. So, this is putting that back in so we can continue to send the minor misdemeanor ticket to the Court.

AN ORDINANCE TO AMEND SECTION 779.02 "PUBLIC VEHICLE LICENSE REQUIRED" OF CHAPTER 779 "TAXICABS" OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA, AND DECLARING AN EMERGENCY

Councilman Crossman – It looks as if the State of Ohio is exempting Uber, Lyft, and other ride share companies from obtaining licenses for taxi cabs. Is that correct?

Mr. Weinreich – The Law Department, brought to their attention, that state law was changing to create this exemption for Uber type operations and advised that we amend our local ordinance to comply with state law. This is on Suspension of the Rules because the change in the state law takes effect March 23<sup>rd</sup>.

Mr. Brennan – So, basically, they are exempt from our local ordinances.

Mr. Weinreich - Correct.

Mr. Brennan - So, we have no way of regulating them as a municipality.

Mr. Weinreich – That is correct. The state law has chosen to exempt them from licensing and this is to comply with state law.

Councilman Tuma – What would the legislative intent behind exempting them. It seems like you would want to regulate them.

Mr. Weinreich – I would defer to the Law Department. I can't speak to the legislative intent at the state level.

Mr. Miller – Why the state legislature did that, I can't tell you but the import of what the general assembly did was that they made the law so that our codified ordinances is inconsistent. Our regulatory system is different than what state law provides. So, they are saying local municipalities can not regulate transportation network companies, which is Uber, Lyft and those sorts of operations. So, we have to change our ordinance to conform with state law.

Mr. Brennan – My follow up to that is, normally when the state makes some type of change to the law and they regulate something, usually we have to adopt the regulations and codify them in our ordinances.

Mr. Miller – They have preempted that function. They state the local municipalities may not regulate Uber, Lyft and other transportation companies.

Mr. Brennan – Are there state regulations on them or not? What do our Police do? Do they know what the regulations are regarding these Uber drivers?

Mr. Miller - I'm not sure that they are doing that. They are just saying that cities may not regulate those.
