### **LEGISLATIVE COMMENT**

Gary Konieczka - 3115 Tuxedo Avenue - Talked about first reading for the fireworks display.

Mayor DeGeeter - Mr. Konieczka is here to talk about fireworks display and has had conversations with Councilwoman Saban. He has also had some discussions with our Council President. On Friday, I did speak with the Sponsor of the fireworks legislation, Mr. Brochetti, who agrees with this. The Service Director, Chief of Staff, Recreation Director, Mayor and Council President met to talk about the fireworks protocol. Since this is a Parma Youth Commission project, they are raising the funds. What we will be doing is working to do a substitute legislation that still would go out to bid. We will reduce the amount. The amount before you is up to \$40,000. We will reduce the amount and look to see what date we will do this. We will also be putting in additional whereas clauses that will note that this is in celebration of the 200th Settling of Parma. I have talked with our Fire Chief who will be working with the Youth Commission. Chief will make the recommendation back on which folks to pick.

I know Mr. Konieczka has a fireworks company. We will likely get 3 bids and possibly 4 on this to review. Again, the reading is just on first and we will be doing some changes on the legislation as we go through the process. I am sure we will keep Mr. Konieczka up to speed on what is happening.

Gary Konieczka - When I was talking to the Fire Chief, he was talking about the bid at \$25,000. Anything above \$25,000 has to go out to bid. What I am proposing to City Council tonight, working out a deal to do the Fireworks display for under \$25,000. Including what you are paying for 3 separate entities for the City of Parma, which then would not have to go to bid.

Mr. Tuma - Again, this is not where we go back and forth and debate. This would have been better off in Committee. I would recommend contacting Council President Brennan and speaking with him directly.

Mr. Konieczka - I did. And it was still up in the air. We are located in the City of Parma. I pay City taxes. Just to bring up one point that the Mayor of North Olmsted, had his Bicentennial last year. They did not put theirs up to bid since it was under \$25,000. They supported the fireworks company that was in their City.

Mr. Tuma - That is fine. There is a process that is in place, and I would recommend speaking with whoever is in charge of that process (Service or Safety Director). They will keep you posted.

Councilman Crossman - Is Mr. Brochetti the point person on this?

Mayor DeGeeter - Have Mr. Konieczka email a written proposal to Council

President and cc all of us on this so we have something to look at moving forward.

Councilwoman Lime - Asked the Service Director about the \$360 from 10/7/14 for the Arborist recertification.

Service Director Higgins - Yes, we had 2 of our people get recertified as Arborist's in October of 2014. We had a purchase order at that time for the cost. Company never sent us a bill and we never paid them. Through their auditing process they realized they never invoiced us so they invoiced us and we need to pay that bill. The other one that I would like to talk about is from 2014. One is a hydrant and thanks to the Law Department, I have a copy of the check that was reimbursed for that bill.

Councilwoman Lime - Who are the two certified Arborists?

Service Director Higgins - Andy Edwards and Jeff Howe.

Councilwoman Lime - OK and has their recertification been done again so we should expect another bill in 2017 for services from 2015?

Service Director Higgins - I am not sure how often they need to recertify. I did not send them to school last year so you should not be seeing a bill.

Councilman Crossman - There are a couple \$10,000 charges on these post certs. If someone could address those? One looks like a comm center charge and the other a treatment charge from the courts.

Acting Safety Director Weinreich - The Comm Center is for legal fees attending to the notes that were issued.

Law Director Dobeck - Those are the legal fees for the issuants costs for the renewal of the note for the Comm Center.

Auditor Day - I know that Matt Talbot is an addiction recovery institution. So it has to do with folks of the courts receiving treatment.

Law Director Dobeck - I really cannot clarify anymore. That is exactly what it is. Sometimes these are indigent defendants and sometimes they are not and get reimbursed by the court. I know we had one just recently with Councilwoman Lime that took about a year and half but we did ensure that there was reimbursement of those funds.

Councilman Crossman - That is why I asked. Are these reimbursable expenses? Mr. Tuma - The Law Director will look into that.
