APPOINTMENTS AND CONFIRMATIONS

Mr. Dipierro – Stated that Council held a Special Meeting on February 1, 2023 to interview the 4 candidates for Ward 1 Councilperson. Invited each candidate to come forward to briefly introduce themselves to the administration and public.

Russell Potoma – Good evening, I am Russell Potoma. I've lived at 8006 Fernhill Avenue in Ward 1 for the last 10 years. I'm married, my wife is a kindergarten teacher at Dentzler. I've worked for the City of Solon as a Correctional Officer full time for the past 7 years. I've done the union for 5 years and I've been a field training officer for the last 6 years. Thank you.

James Miller – Good evening, everybody. My name's James Miller, I live at 11470 Richard Drive in Parma, I've lived there for about 7 years. I have been in Parma for almost 15 years. I am married with 2 children; my wife is a registered nurse at Metro Health. I am a truck driver plus concrete finisher. I have a son who is going to be 13 next week, he is very active in Parma Parks and Rec, he's active in baseball, basketball, football for Greenbriar. My daughter is 17, she is going to be going to college here soon. I just want to let everyone know that I may not be the very one that you want to pick for Council, I am probably the least qualified for it, but if you guys pick me, I will do my best to bring Ward 1 all together and to make sure that Ward 1 is one of the best in Parma. Thank you.

Monica Wilson – Good evening everyone, I'm Monica Wilson. As a Parma resident for over 30 years, I know the value of this City Council position and its importance to creating meaningful policy and public engagement. Growing up in a working-class union household along with the values instilled in me by my mother and father has prepared me for this opportunity to service the citizens of Parma. Upon moving to Ohio, I utilized my BS and MS Chemical Engineering degrees in the paints and coatings industry where I work now as a global product manager. This position requires an advanced level of expertise and the proficiency to work across languages and cultures to successfully manage global multi million projects. This working experience and aptitude to work with people from all background positions me as a qualified applicant to make the right decisions for our citizens. I listen and act to resolve problems and implement solutions to everyone's benefit. I will work on the bread-and-butter issues, such as roads, security, city services, along with looking for long term solutions to increase the quality of life in our Ward 1 community. My personal motto is that there is nothing more important on earth than a human being. All people must be at the table to create a better community and that's why I want to be the voice of Ward 1, Parma, Ohio. Thank you.

Dan McCarthy – Hi, I'm Daniel P. McCarthy. I've lived in Ward 1 all of my life, in the same house, 61 years. There are fine candidates here, but I am the only candidate who can demonstrate a long track record of proven results obtained for residents in Ward 1 as well as Parma, Parma Heights, and Seven Hills. I have many civic accomplishments. A current one I have is Chief Bobak hooked me up with Captain Zarzeczny because I was very dismayed that the Citizens Police Academy did not have enough people and they had to cancel it. This is something I did, so it's very near and dear to my heart so I am collaborating with him to try to promote this because it's a bridge to the community and a very important tool. I've got business ties, awards, recognitions, I have a lot of personal relationships from St. Bridget's. I'll set the record straight, I remember Vito Dipierro's first day in Council. I thought he did a great job and I declined to ever run against him, even though I was asked to more than once. When it became apparent to me that Vito would be sitting there in the summer and fall, I made it clear that I now wanted to run for the seat. As soon as it was possible, I pulled petitions. I went out that week, I spent 5 hours and 20 minutes and got 50 signatures on my petition. I think it was easy because when I knock on doors in my ward, people know me. Sometimes I went to kindergarten with them, and their parents are still there. So, I think it's really important and lot of my residents felt the same thing, that someone that has grown up here and really knows Ward 1 can represent Ward 1 the best. One of my favorite writers Phil Ochs said that in every deep tragedy there is always something present that is ridiculous. We are filled up with that in America. I think the George Santos situation kind of reflects on that. It's really important for voters to find out everything about candidates before the election, not afterwards. I think my life is an open book, my views are very well known, 14 years of publishing the paper I have written and articulated many times. It's all out there, I'm not concealing anything or scrubbing my social media, you can find out everything I've ever thought or said is a public

record. Literally, I am an open book. I think we had a good presentation on Wednesday, I'm not going to go through all that again, you've all heard it. I'm just going to say that my fate is in your hands, the fate of ward 1 and all the residents is in your hands tonight. Thank you very much for your time.

Mr. Dipierro – Thanked applicants for coming forward. Stated that there are a lot of good options. Stated that the roll of Council will now be called and that each Council Member should state the name of candidate that they are voting for.
