Bulk Regulations

Consider bulk as items that cannot be broken down and placed into your recycling or trash cart. These items include:

- · Household furniture, washer/dryers, TVs, tables, swing sets, mattress/box springs, chairs, etc.
- · Appliances: refrigerators and freezers; doors removed
- · Carpet and wood should be cut to 3 feet in length, no more than 40 pounds, and be rolled and tied/ bundled together
- · Boxes should be broken down, no longer than 4 feet in length, weighing no more than 40 pounds and must be tied/bundled
- · Please be sure to completely wrap any mattress or box springs in plastic.
- · Bulk items must be placed within 3 feet of the curb and 3 feet away from recycling/trash cart and yard waste bags or cans.
