FIRST CASE OF APPEAL

Sandra L Nagy 4409 Woodrow Parma, Ohio 44134 PPN: 471-11-028

Section 1529.23(a)(2) - FENCES, HEDGES & TRELLISES

Fences shall be permitted only in rear yards. In no case shall fences extend any further towards the street than 5 feet past the side door. If no side door exists, then the fence shall be no further towards the street than the rear of the residential structure.

Proposal to place fencing and gate 20' further of the back corner of the house.

Variance would result in the installation of fence 20 feet further forward of rear corner of a house than code allows.

SECOND CASE OF APPEAL

Mackenzie Simmons 7502 Dresden Ave. Parma, Ohio 44129 PPN: 443-05-031

Section 1529.23(a)(2) – FENCES, HEDGES & TRELLISES

Fences shall be permitted only in rear yards. In no case shall fences extend any further towards the street than 5 feet past the side door.

Proposal to place fencing and gate 6'5 feet forward of the the side door of the house.

Variance is to installation of a fence 18 inches further forward of the side door than code allows.

THIRD CASE OF APPEAL

Regina e Pettegrew 8561 Pinehurst Dr. Parma, Ohio 44129 PPN: 455-14-034

Section 1529.23(a)(2) – FENCES, HEDGES & TRELLISES

Fences shall be permitted only in rear yards. In no case shall fences extend any further towards the street than 5 feet past the side door. If no side door exists, then the fence shall be no further towards the street than the rear of the residential structure.

Proposal to place fencing 8 feet further of the rear corner of the house.

Variance is to installation of a fence forward of the rear corner of the house 8 feet more than code allows.

FOURTH CASE OF APPEAL

Stan and Heidi Gabric 7612 Hidden Valley Parma, Ohio 44130 PPN: 455-27-024

Section 1529.39(a)(5) – ACCESSORY AND APPURTENANT BUILDING USED IN RESIDENTIAL DISTRICTS

The maximum size of an accessory structure shall be 240 square feet. The maximum height of an accessory or outbuilding shall be 12 feet from the grade.

Proposal to build a shed 264 square feet, 14 feet tall shed.

The variance would result in allowing an accessory structure to be constructed that is 24 square feet more in area and 2 feet taller in height than code allows.
