AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A CONTRACT UNDER THE STATE OF OHIO COOPERATIVE PURCHASE PROGRAM FOR THE LEASE/PURCHASE OF ONE (1) HENDERSON 10' MUNIBODY/HOIST/PLOW HITCH; 10' HENDERSON PLOWS/ELECTRICAL SYSTEM/CENTRAL HYDRAULICS/AUGER CONVEYOR SYSTEM FOR THE PARMA SERVICE DEPARTMENT, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Director of Public Service is hereby authorized to enter into a contract with Henderson Truck Equipment, under the State of Ohio Cooperative Purchase Program for the five (5) year lease/purchase of one (1) Henderson 10' Munibody/Hoist/Plow Hitch; 10' Henderson Plows/Electrical System/Central Hydraulics/Auger Conveyor System for the Parma Service Department (ODOT State Contract #065-14) at a cost not to exceed \$66,829.00, at a lease rate not to exceed five percent (5%).

Section 2. That the Director of Public Service is hereby authorized to execute said contract and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That funds for said lease/purchase shall be paid from Fund No. 405-405-Capital Improvements and Account No. 68006-22313-Equipment and Facilities.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary in order to replace Service Department vehicles that are out of service, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
