AN ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY TO ENTER INTO A CONTRACT UNDER AN EMERGENCY CIRCUMSTANCE WITH SIMPLEXGRINNELL FOR THE EMERGENCY REPLACEMENT OF THE TOA INTERCOM SYSTEM AT THE PARMA JUSTICE CENTER, AND DECLARING AN EMERGENCY

WHEREAS, the TOA Intercom System is malfunctioning at the Parma Justice Center and a replacement is necessary and constitutes a clear and present emergency circumstance pursuant to Ohio R.C. 735.051; and,

WHEREAS, competitive bidding would delay the timely replacement of such nuisance at the present time to the detriment of the Parma Justice Center;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Mayor and the Director of Public Safety are hereby authorized to enter into a contract under a clear and present emergency circumstance with SimplexGrinnell for the emergency replacement of the TOA Intercom System at the Parma Justice Center at a cost not to exceed \$46,968.00 (State of Ohio pricing).

Section 2. That the Mayor and the Director of Public Safety are hereby authorized to execute said contract and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That funds for said services shall be paid from Fund No. 405-405-Capital Improvements, Account No. 68006-00011-Equipment & Facilities.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that the replacement is necessary at the earliest date possible, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
