A RESOLUTION TO APPROVE AND ADOPT THE EQUALIZATION BOARD REPORT FOR SANITARY SEWER IMPROVEMENTS FOR BAGLEY ROAD, PLEASANT VALLEY ROAD, A PORTION OF WEST 130<sup>TH</sup> STREET AND A PORTION OF NORTH LINDEN LANE IN THE CITY OF PARMA, AND DECLARING AN EMERGENCY

WHEREAS, Ordinance No. 104-14, adopted on June 16, 2014, appoints an Assessment Equalization Board to hear and determine objections filed with respect to the Bagley Road, Pleasant Valley Road, a portion of West 130<sup>th</sup> Street and a portion of North Linden Lane Sanitary Sewer Project in the City of Parma; and,

WHEREAS, the Assessment Equalization Board has concluded the hearings for this Sanitary Sewer Project and has prepared the necessary Equalization Board Report;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the report of the Assessment Equalization Board appointed by Ordinance No. 104-14 is hereby approved by this Council, and the estimated special assessments previously prepared and filed in the office of the Clerk of Council, and as equalized by the Assessment Equalization Board are approved and adopted, with a copy of said report attached hereto as Exhibit "A".

Section 2. The Assessments as equalized by the Assessment Board of Equalization are directed to be filed in the office of the Clerk of Council.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order for the Report to be approved and adopted by this Council and to enable the project to proceed, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
