A RESOLUTION REQUESTING THE BUILDING COMMISSIONER TO INSTITUTE SUMMARY NUISANCE ABATEMENT OF PERMANENT PARCEL NUMBERS 444-30-007, 4202 SNOW ROAD AND 444-30-008, 4208 SNOW ROAD, PARMA, OHIO, AND DECLARING AN EMERGENCY

WHEREAS, Permanent Parcel Numbers 444-30-007, 4202 Snow Road and 444-30-008, 4208 Snow Road, Parma, Ohio, are considered a public nuisance by reason of the condition in which the same are permitted to be or remain; and,

WHEREAS, Permanent Parcel Numbers 444-30-007, 4202 Snow Road and 444-30-008, 4208 Snow Road, Parma, Ohio, are a public nuisance due to the exterior violations including peeling wood surfaces; discolored siding; damaged entrance walkway; unregistered vacant property; necessary clean-up of yard; overgrown hedges/bushes; unlicensed/inoperable vehicle; high grass and weeds; and damaged gutters/downspouts; and,

WHEREAS, Notices of Violation have been issued on May 1, 2013, and June 12, 2014;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Building Commissioner is hereby requested to act pursuant to the Summary Abatement procedures, Parma Codified Ordinance Section 1527.02 and Ohio Revised Code Sections 715.261 and 715.47, to determine whether Permanent Parcel Numbers 444-30-007, 4202 Snow Road and 444-30-007, 4208 Snow Road, Parma, Ohio, are a public nuisance.

Section 2. That the Building Commissioner, if he finds that a public nuisance exists and that the public health, safety, and welfare may be in immediate danger pursuant to Parma Codified Ordinance Section 1527.02(a) and Ohio Revised Code Sections 715.261 and 715.47, is hereby requested to cause a written notice to be served on the titled owner outlining his findings with respect to the existence of a public nuisance that further states that unless the owner thereof causes the abatement of the public nuisance within 24 hours after service of the notice, the same will be abated by the City at the expense of such owner, to be levied against the tax duplicate of said owner(s).

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary due to the condition of the properties, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
