A RESOLUTION AUTHORIZING THE PARMA PUBLIC HOUSING EXECUTIVE DIRECTOR TO ENTER INTO AN AGREEMENT WITH KEYBANK ENTERPRISE COMMERCIAL PAYMENTS, PUBLIC SECTOR, TO PROVIDE PREPAID DEBIT CARDS FOR PARTICIPANTS OF LOW INCOME PUBLIC HOUSING, HOUSING CHOICE VOUCHER PROGRAM, AND OWNERS DOING BUSINESS WITH THE HOUSING CHOICE VOUCHER PROGRAM THAT DO NOT HAVE ACCESS TO EITHER CHECKING OR SAVINGS ACCOUNTS, AND DECLARING AN EMERGENCY

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Parma Public Housing Executive Director is hereby authorized to enter into an agreement with KeyBank Enterprise Commercial Payments, Public Sector, to provide prepaid Debit Cards for participants of Low Income Public Housing, Housing Choice Voucher Program, and owners doing business with the Housing Choice Voucher Program that do not have access to either checking or savings accounts. There is no cost to Parma Public Housing Agency for this service.

Section 2. That the Parma Public Housing Executive Director is hereby authorized to execute said agreement and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this service is necessary in order to provide prepaid debit cards to program participants/residents and owners doing business with the Parma Public Housing Agency, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
