RESOLUTION NO. 159-15

A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SAFETY TO ISSUE A PERMIT TO TRANSPORT INTO THE TERRITORIAL LIMITS OF THE CITY OF PARMA, FIREWORKS AND FIREWORK SUNDRIES FOR A PYROTECHNIC DISPLAY IN CONJUNCTION WITH A COMMERCIAL BEING FILMED AT DAGWOOD SANDWICH SHOP, LOCATED AT 5310 STATE ROAD/4003 TUXEDO AVENUE, IN THE CITY OF PARMA, AND DECLARING AN EMERGENCY

WHEREAS, the Fire Chief of the City of Parma, notwithstanding the thirty day processing time, shall require a Resolution adopted by Council permitting a person to transport, convey, and bring into the City, fireworks and firework sundries for the purpose of pyrotechnic displays (C.O. 1305.04(f)) in conjunction with the production of the commercial;

NOW, THEREFORE; BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Director of Public Safety of the City of Parma be, and he hereby is, authorized and directed to issue a permit to transport, convey, and bring into the territorial limits of the City of Parma, Ohio, fireworks and firework sundries for the purpose of, and in conjunction with, a commercial being filmed at Dagwood Sandwich Shop, on Wednesday, July 22, 2015, from 9:00 p.m. to midnight, located at 5310 State Road/4003 Tuxedo Avenue, in the City of Parma, by holding pyrotechnic displays during the aforementioned date; provided that a bond or liability insurance is furnished to the City of Parma as blanket coverage for bodily injury and property damage as required by Parma Codified Ordinance Section 1305.04(g) indemnifying and saving harmless the City of Parma and the permittee from any and all liabilities, by reason of or arising out of, the issuance of such permit; and provided further, that all conduct in the affairs of said pyrotechnic display shall be under the supervision of, and all actions undertaking and conduct of said affair, be subject to the complete approval and supervision of the Chief of the Division of Fire, and the Chief of the Division of Police, Department of Public Safety, pursuant to Section 1305.04 of the Codified Ordinances of the City of Parma.

Section 2. Should inclement weather prohibit the aforementioned filming of the commercial on the date set forth, i.e., Wednesday, July 22, 2015, said filming shall be permitted at a later date suitable to the vendor and Dagwood Sandwich Shop, to be determined by written agreement between the City and the applicant.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Res. authorizing and directing the Director of Public Safety to issue a permit to transport into the territorial limits of the City of Parma, fireworks and firework sundries for a pyrotechnic display in conjunction with a commercial being filmed at Dagwood Sandwich Shop, located at 5310 State Road/4003 Tuxedo Avenue, in the City of Parma, and declaring an emergency

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary in order to have this permit in place for the filming of the fireworks display, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
