AN ORDINANCE TO AMEND ORDINANCE NO. 264-07 TO ACCEPT A NEW “PRICING SCHEDULE” FOR THE MEMORANDUM OF AGREEMENT WITH CUYAHOGA COUNTY FOR THE MAINTENANCE OF SANITARY AND STORM SEWERAGE AND WATER SYSTEMS WITHIN THE CITY OF PARMA, OHIO, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That Ordinance No. 264-07, passed March 10, 2008, and amended by Ordinance No. 205-11, adopted September 6, 2011, is hereby amended to accept a new “Pricing Schedule”, marked Exhibit “A” to the Memorandum of Agreement with Cuyahoga County for the Maintenance of Sanitary and Storm Sewerage and Water Systems within the City of Parma, with the revised “Pricing Schedule” attached as Exhibit “A” to this Ordinance.

Section 2. That the previous “Pricing Schedule”, marked Exhibit “A” to the Memorandum of Agreement with Cuyahoga County for the Maintenance of Sanitary and Sewerage and Water Systems within the City of Parma, as adopted by Ordinance No. 264-07, passed March 10, 2008, and amended by Ordinance No. 205-11, adopted September 6, 2011, as it existed heretofore, is hereby repealed.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary in order to reallocate the funds collected and to ensure the funds are available for the services of the Cuyahoga County Department of Public Works (formerly Cuyahoga County Sanitary Engineer) for the storm sewers, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
