

ORDINANCE NO. 109-16

AN ORDINANCE TO AMEND A PORTION OF
SUBSECTION (c) OF SECTION 351.18
“OVERNIGHT PARKING DURING WINTER
MONTHS” OF THE CODIFIED ORDINANCES
OF THE CITY OF PARMA, AND DECLARING
AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That a portion of subsection (c) of Section 351.18 “Overnight Parking During Winter Months” of the Codified Ordinances of the City of Parma, which presently reads as follows:

“351.18 OVERNIGHT PARKING DURING WINTER MONTHS.

...

(c) (1) The Director of Public Safety is hereby authorized to issue special permits allowing parking during the prohibited time under this section where certain hardships exist. Application must be made by the resident at a given location outlining specifically the make, model and other descriptive features of each vehicle involved, as well as the license number assigned to that vehicle. The owner will be required to renew application for any such permit to cover each separate snow season and such permits can be rescinded upon violation of the procedures or upon change of the circumstances and conditions which created the reason for hardship variance.”

...

is hereby amended to read as follows:

“351.18 OVERNIGHT PARKING DURING WINTER MONTHS.

...

(c) (1) The Director of Public Safety is hereby authorized to issue special permits allowing parking during the prohibited time under this section where certain hardships exist. Application must be made by the resident at a given location outlining specifically the make, model and other descriptive features of each vehicle involved, as well as the license number assigned to that vehicle. **THE APPLICANT SHALL PAY A NON-REFUNDABLE OVERNIGHT WINTER PARKING PERMIT FEE FOR EACH PERMIT, FOR THE PERIOD OF NOVEMBER 1ST THROUGH APRIL 15TH, AS SPECIFIED IN CHAPTER 185 OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA, WHICH FEE SHALL BE PAID AT THE TIME THE APPLICATION IS SUBMITTED.** The owner will be required to renew application **AND PAY PERMIT FEE** for any such permit to cover each separate snow season and such permits can be rescinded upon violation of the procedures or upon change of the circumstances and conditions which created the reason for hardship variance.”

...

Section 2. That only that portion of subsection (c) of Section 351.18 "Overnight Parking During Winter Months" of the Codified Ordinances of the City of Parma, as it existed heretofore, is hereby repealed.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to make this addition in this Section in the Codified Ordinances in the near future, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
