AN ORDINANCE TO AMEND SUBSECTION (a) OF SECTION 698.08 “USE OF CITY JAIL, REIMBURSEMENT OF CONFINEMENT COSTS BY GOVERNMENT ENTITIES” OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA RELATIVE TO THE INITIAL BOOKING/REGISTRATION FEE, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That subsection (a) of Section 698.08 “Use of City Jail, Reimbursement of Confinement Costs by Governmental Entities” of the Codified Ordinances of the City of Parma, which presently reads as follows:

“698.08 USE OF CITY JAIL; REIMBURSEMENT OF CONFINEMENT COSTS BY GOVERNMENTAL ENTITIES.

(a) Governmental entities shall pay to the City, for the use of the Parma Municipal Jail Facility for the housing of prisoners, a sum of eighty dollars (\$80.00) per day per prisoner.”

...

Is hereby amended to read as follows:

“698.08 USE OF CITY JAIL; REIMBURSEMENT OF CONFINEMENT COSTS BY GOVERNMENTAL ENTITIES.

(a) Governmental entities shall pay to the City, for the use of the Parma Municipal Jail Facility for the housing of prisoners, a sum of eighty dollars (\$80.00) per day per prisoner, **AND THE INITIAL BOOKING/REGISTRATION FEE PER JAIL CONFINEMENT IMPOSED PURSUANT TO SECTION 185.04(a).**”

Section 2. That only subsection (a) of Section 698.08 “Use of City Jail; Reimbursement of Confinement Costs by Governmental Entities” of the Codified Ordinances of the City of Parma, as it existed heretofore, is hereby repealed.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to amend this section to include this newly imposed fee by July 1, 2016, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
