AN ORDINANCE TO AMEND SUBSECTION 1519.02(b) IN SECTION 1519.02 “APPLICATION OF CHAPTER” OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That Subsection 1519.02(b) of Section 1519.02 “Application of Chapter” of the Codified Ordinances of the City of Parma, which presently reads as follows:

1519.02 APPLICATION OF CHAPTER.

Signs shall be designed, erected, altered, moved and maintained, in whole or in part, in accordance with the regulations set forth in this chapter.

The provisions of this chapter shall not amend or in any way interfere with other codes, rules or regulations governing traffic signs within the City. This chapter shall not govern the display of the following signs:

...

(b) Signs of the Municipal, State and Federal governments;

is hereby amended to read as follows:

1519.02 APPLICATION OF CHAPTER.

Signs shall be designed, erected, altered, moved and maintained, in whole or in part, in accordance with the regulations set forth in this chapter.

The provisions of this chapter shall not amend or in any way interfere with other codes, rules or regulations governing traffic signs within the City. This chapter shall not govern the display of the following signs:

...

(b) Signs of or for the use of the Municipal, State and Federal governments, and the Greater Cleveland Regional Transit Authority (RTA);

Section 2. That only that portion of Subsection 1519.02(b) of Section 1519.02 “Application of Chapter” of the Codified Ordinances of the City of Parma, as it existed heretofore, are hereby repealed.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to allow the RTA to perform at project schedule, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
