AN ORDINANCE TO AMEND THE HEADING AND SECTIONS 1 AND 3 OF ORDINANCE NO. 203-17, FOR THE ORCHARD PARK DRIVE STORM SEWER PROJECT, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Heading of Ordinance No. 203-17, passed August 6, 2018, which presently reads as follows:

“An Ordinance authorizing the Mayor and the Director of Public Service to advertise for and enter into a contract with the lowest and best bidder for the Orchard Park Drive Storm Sewer Project in the City of Parma, and declaring an emergency”

Is hereby amended to read as follows:

“An Ordinance authorizing the Mayor and the Director of Public Service to advertise for and enter into a contract with the lowest and best bidder for the Orchard Park **AND FOREST HILLS STORM SEWER IMPROVEMENT** Project in the City of Parma, and declaring an emergency”

Section 2. That Section 1 of Ordinance No. 203-17, passed August 6, 2018, which presently reads as follows:

“That the Mayor and the Director of Public Service are hereby authorized to enter into a contract with Catts Construction, Inc., the lowest and best bidder, for the Orchard Park Drive Storm Sewer Project, in the City of Parma, at the bid price of \$369,620.95 except for contract modifications pursuant to the requirements of Ohio Revised Code Section 735.07.”

is hereby amended to read as follows:

“That the Mayor and the Director of Public Service are hereby authorized to enter into a contract with Catts Construction, Inc., the lowest and best bidder, for the Orchard Park **AND FOREST HILLS STORM SEWER IMPROVEMENT** Project, in the City of Parma, at the bid price of **\$612,322.65** except for contract modifications pursuant to the requirements of Ohio Revised Code Section 735.07.”

Section 3. That Section 3 of Ordinance No. 203-17, passed August 6, 2018, which presently reads as follows:

“That funds for said purchase shall be paid from Fund No. 451-451-Orchard Park Storm Sewer; Account Nos. 62110-20317-Professional Services and 62255-20317-Easement, in the amount of \$369,620.95.”

is hereby amended to read as follows:

“That funds for said purchase shall be paid from Fund No. 451-451-Orchard Park Storm Sewer; Account Nos. 62110-20317-Professional Services and 62255-20317-Easement, in the amount of **\$612,322.65.**”

Section 4. That the Heading, Section 1 and Section 3 of Ordinance No. 203-17, passed August 6, 2018, as they existed heretofore, are hereby repealed.

Section 5. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary due to the additional improvements on Forest Hills needed to complete this project, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
