A RESOLUTION DECLARING THE NECESSITY AND INTENT OF THE CITY OF PARMA TO APPROPRIATE SANITARY SEWER EASEMENTS IN CERTAIN REAL PROPERTIES KNOWN AS PERMANENT PARCEL NUMBER 445-14-002 LOCATED AT 1450 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-14-003 LOCATED AT 1400 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-001 LOCATED AT 1350 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-002 LOCATED AT 1200 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-003 LOCATED AT 1300 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-004 LOCATED AT 1250 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-005 LOCATED AT 904 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-006 LOCATED AT 1020 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-007 LOCATED AT 1100 OLD ROCKSIDE ROAD, PERMANENT PARCEL NUMBER 445-15-008 LOCATED AT 1122 OLD ROCKSIDE ROAD, AND PERMANENT PARCEL NUMBER 445-15-017 LOCATED AT 1000 BROADROCK COURT, IN THE CITY OF PARMA, AND DECLARING AN EMERGENCY

WHEREAS, by virtue of the Constitution of the State of Ohio and Chapters 163 and 719 of the Ohio Revised Code, the City of Parma has the power and authority to appropriate real property for the purpose of installing, using, maintaining and keeping in repair a sanitary sewer that the City of Parma deems conducive to the general welfare; and,

WHEREAS, the City wishes to acquire easements across certain properties known as Permanent Parcel Number 445-14-002 located at 1450 Old Rockside Road, Permanent Parcel Number 445-14-003 located at 1400 Old Rockside Road, Permanent Parcel Number 445-15-001 located at 1350 Old Rockside Road, Permanent Parcel Number 445-15-002 located at 1200 Old Rockside Road, Permanent Parcel Number 445-15-003 located at 1300 Old Rockside Road, Permanent Parcel Number 445-15-004 located at 1250 Old Rockside Road, Permanent Parcel Number 445-15-005 located at 904 Old Rockside Road, Permanent Parcel Number 445-15-006 located at 1020 Old Rockside Road, Permanent Parcel Number 445-15-007 located at 1100 Old Rockside Road, Permanent Parcel Number 445-15-008 located at 1122 Old Rockside Road, and Permanent Parcel Number 445-15-017 located at 1000 Broadrock Court in the City of Parma, and further described in Exhibit "A" attached hereto for such purposes.

NOW, THEREFORE; BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Council and the Administration of the City of Parma consider it necessary and declares its intention to appropriate easements across the properties known as Permanent Parcel Number 445-14-002 located at 1450 Old Rockside Road, Permanent Parcel Number 445-14-003 located at 1400 Old Rockside Road, Permanent Parcel Number 445-15-001 located at 1350 Old Rockside Road, Permanent Parcel Number 445-15-002 located at 1200 Old Rockside Road, Permanent Parcel Number 445-15-003 located at 1300 Old Rockside Road, Permanent Parcel Number 445-15-004 located at 1250 Old Rockside Road, Permanent Parcel Number 445-15-005 located at 904 Old Rockside Road, Permanent Parcel Number 445-15-006 located at 1020 Old Rockside Road, Permanent Parcel Number 445-15-007 located at 1100 Old Rockside Road, Permanent Parcel Number 445-15-008 located at 1122 Old Rockside Road, and Permanent Parcel Number 445-15-017 located at 1000 Broadrock Court in the City of Parma, and as further described in Exhibit "A", for the public purpose of installing, using, maintaining and keeping in repair a sanitary sewer that the City of Parma deems conducive to the general welfare.

Section 2. That the Mayor is hereby authorized and directed to cause written notice of the adoption of this Resolution to be given to the property owners, persons in possession, or persons having an interest of record in the properties. The notices shall be served and returned according to law.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for further reason that this measure is necessary in order to initiate the process of acquiring the aforesaid easements in the Properties for the above stated purposes, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
