

ORDINANCE NO. 45-2020

AN ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE PURCHASE OF PORTABLE RADIO EQUIPMENT, AND DECLARING AN EMERGENCY

WHEREAS, The City of Parma was awarded the Regional Radio Grant and it will be divided between four (4) cities: Parma, Broadview Heights, Seven Hills and Brooklyn Heights; and,

WHEREAS, The Assistance to Firefighters FY 2018 Grant will pay \$421,363.63, with the City’s contributing portion of \$42,136.37 totaling \$463,500.00. Cuyahoga County will reimburse the City’s portion (10%) in the amount of \$42,136.37.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Mayor and Director of Public Safety are hereby authorized to enter into a contract with _____, the lowest and best bidder, for the purchase of portable radio equipment at the bid price of \$_____ except for contract modifications pursuant to the requirements of Ohio Revised Code §735.07. A copy of said contract is attached in substantially similar form as Exhibit “A”.

Section 2. That the Mayor and Director of Public Safety are hereby authorized to execute said contract and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That funds for said purchase shall be paid from Fund No. 105-105 – Fire Levy; Account No. 63077-00000 – Radio & Communications; and Fund No. 127-127 – Assistance to Firefighters FY 2018; Account No. 63077-00000 – Radio & Communications. The reimbursement will be deposited into account 105-105-43003-00000 Local Grant Funds.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to enter into this contract at the earliest possible date, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
