A RESOLUTION TO RECEIVE AND ACCEPT \$327,685.00 IN CDBG-CV FUNDS AND TO AMEND THE 2019 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL PLAN IN THE CITY OF PARMA, AND DECLARING AN EMERGENCY

WHEREAS, the Department of Housing and Urban Development has allocated an additional \$327,685.00 in Round 3 CDBG-CV funds from the CARES Act to the City of Parma; and,

WHEREAS, this funding is meant to supplement Round 1 CDBG-CV funding for a total CDBG-CV relief package of \$899,903.00; and,

WHEREAS, CDBG-CV funding is part of Parma’s 2019 Annual Plan with said Plan requiring an amendment if any program budget changed +/- \$10,000.00; and,

WHEREAS, the \$327,685.00 in additional funding requires an additional amendment to the FY 2019 Annual Plan programs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Mayor or his designee are hereby authorized to receive and accept \$327,685.00 in CDBG-CV funding and amend the 2019 Annual Plan as presented and submit for formal final approval by the Department of Housing and Urban Development, with a copy of said Plan attached as Exhibit ‘A’.

Section 2. That the Mayor or his designee are hereby authorized to receive and accept the additional funds and accept the amendment to the FY 2019 Annual Action Plan, and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to amend the 2019 CDBG Annual Plan, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
