

Agreement to Provide Medical Care at the Parma Detention Center

This agreement confirms that Arnold J. Feltoon, MD Inc. (hereinafter referred to as "Professional Corporation"), will provide medical care for the Parma Detention Center located at 5555 Powers Blvd., Parma, Ohio 44129 (hereinafter referred to as "City" or "Detention Center") (collectively referred to as "the parties"). Unless otherwise notified, medical care will be provided by Arnold Feltoon, M.D., FAAEM, CCHP, a fully licensed, insured, and physician in good standing in the State of Ohio.

Professional Corporation will provide the City with the following services: oversight of the administration of all medications, both prescription and non-prescription given to inmates; review of inmate medical records; coordination of emergency medical care including assessment by the Fire Department paramedics and/or transfer to a hospital; approval of any and all policies pertaining to medical care rendered in the Detention Center; development of standing orders for the administration of non-prescription medications; review of special diet requests; up to one hour per week of scheduled on-site examinations of inmates; communication with other physicians concerning medical care of inmates; screening for communicable diseases when indicated; and any other aspects of medical care related to inmates of the Detention Center. Dr. Feltoon will be available by pager 24 hours a day, seven days a week, and will answer such pages within 30 minutes whenever possible.

Professional Corporation agrees to maintain insurance for any and all potential malpractice or legal liability claims that may arise out of the medical care services Professional Corporation renders at the Parma Detention Center. Professional Corporation agrees to provide the City a copy of its insurance coverage and a copy whenever it is updated.

Professional Corporation agrees to provide alternate medical coverage by another fully licensed, insured, and physician in good standing when Dr. Feltoon is unavailable for more than 12 hours. Professional Corporation agrees to notify the Detention Center management of any such alternate coverage and the expected period of time the coverage will take place.

Professional Corporation will obtain information regarding the notification of inmate requests for medications; notification of special diet requests; and notification of an inmate's request for medical care from Parma Detention Center employees or the inmates themselves. The City of Parma will provide Dr. Feltoon with the following: access to inmates' medical records and booking records if medically applicable; copies of Parma Detention Center policies and procedures for the provision of medical care; and access to any other information that may impact on the medical care of the inmates. The City will also provide a private area and basic medical equipment as deemed necessary by the Parties for the evaluation of an inmate's medical concerns while in the Detention Center.

The parties agree that Professional Corporation is being retained as an Independent Contractor, not an employee of the City. In return for providing such medical services as outlined above, the City of Parma will compensate Arnold J. Feltoon, MD, Inc. a monthly stipend of \$800. Such stipend will be due by the fifteenth of each month to cover the preceding month's services. An invoice will be sent to the City at the beginning of each month for the preceding month's services. Such stipend will cover 24 hour/day on-call services, up to one hour weekly of on-site services, as well as all other services as listed above.

This agreement shall commence on May 1, 2022 and shall be in effect for a period of (1) one year. This agreement will renew for additional (1) one year terms in the absence of written notice of termination provided by one party to the other 60 days prior to the termination date.
