**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

**Applicability.** The Form HUD-50075-HCV is to be completed annually by HCV-Only PHAs. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** - A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

(24 CFR §903.7(o)).

Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

The agency continues to maintain its eligibility and apply for additional housing choice vouchers as they become available.

The agency continues to strive for a high performer rating in its SEMAP audit. The agency conducts quality control audits for SEMAP on a quarterly basis.

The agency will continue to improve the accuracy of rent calculations. Continuing education and webinars will be provided to individuals who are responsible for rent calculations and rent determinations.

The agency will continue to eliminate physical participant files by creating electronic files in order to free up space in the office and have one point of accessibility for all employees.

The agency will strive to maintain a lease-up rate of at least 98% in the Housing Choice Voucher Program.

The agency will explore new methods of conducting landlord outreach in order to provide more unit availability for the program. The Security Deposit Assistance Program will assist families to move to areas with less than 10% poverty rate in Cuyahoga County which could result in new landlords signing up to the program.

The agency will continue to work with program participants to become economically self-sufficient through the FSS Program as long as funding is available from HUD. The FSS Program will continue to outreach to new partners such as community organizations, social services and businesses that can provide their resources and expertise in supporting the program goals of the participants. The agency has revised its FSS Action Plan to reflect the new HUD Final Rule and regulations regarding the FSS Program.

The agency continues to strive for a high performer rating in its SEMAP audit. The agency conducts quality control audits for SEMAP on a quarterly basis.

The agency will continue to improve the accuracy of rent calculations. Continuing education and webinars will be provided to individuals who are responsible for rent calculations and rent determinations.

The agency will continue to eliminate physical participant files by creating electronic files in order to free up space in the office and have one point of accessibility for all employees.

The agency will strive to maintain a lease-up rate of at least 98% in the Housing Choice Voucher Program.

The agency will explore new methods of conducting landlord outreach in order to provide more unit availability for the program. The Security Deposit Assistance Program will assist families to move to areas with less than 10% poverty rate in Cuyahoga County which could result in new landlords signing up to the program.

The agency will continue to work with program participants to become economically self-sufficient through the FSS Program as long as funding is available from HUD. The FSS Program will continue to outreach to new partners such as community organizations, social services and businesses that can provide their resources and expertise in supporting the program goals of the participants.
