AN ORDINANCE TO AUTHORIZE THE DISTRIBUTION OF AMERICAN RESCUE PLAN ACT FUNDS TO UNIVERSITY HOSPITALS PARMA MEDICAL CENTER, AND DECLARING AN EMERGENCY

WHEREAS, The City was the recipient of certain American Rescue Plan Act (ARPA) Funds; and

WHEREAS, University Hospitals Parma Medical Center (UH-PMC), the largest employer within the City of Parma, has petitioned the City for an allocation of the ARPA funds awarded to the City for the replenishment of the Intensive Care Unit at UH-PMC, the Cardiac Intensive Care Unit, the Intensive Care Step Down Unit, and the Cardiac Care Step Down Unit, and for the creation of a Food For Life Market at UH-PMC, which incorporates healthy eating and diet with the medical care plans, for the chronically ill persons in the Parma community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to distribute an amount not to exceed \$2000,000.00 of said ARPA funds for continued operations at University Hospitals Parma Medical Center.

Section 2. That the Mayor is authorized to execute said distribution and to take such action and to execute such other documents and amendments, thereto as may be necessary and as are approved by the Law Director.

Section 3. That funds for said distribution of monies shall be paid from Fund No. 192-192 – ARPA; Account Nos. 67310-0000 – Public Health – ARPA and 67320-00000 – Service to Disprop. Community – ARPA.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order to present these funds to University Hospitals Parma Medical Center at the earliest possible date for their continued operations, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
