## ORDINANCE NO. 134-23

AN ORDINANCE AUTHORIZING THE MAYOR AND/OR THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A TWO-YEAR CONTRACT WITH THE CUYAHOGA COUNTY GENERAL HEALTH DISTRICT TO PROVIDE PUBLIC HEALTH SERVICES FOR THE CITY OF PARMA RESIDENTS FOR THE YEARS 2024 AND 2025, APPROPRIATING THE SUM OF \$588,309.00 FOR 2024 AND \$649,168.00 FOR 2025, AND DECLARING AN EMERGENCY

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That the Mayor and/or the Director of Public Service are hereby authorized to enter into a contract with the Cuyahoga County General Health District to provide public health services for the City of Parma residents at the rate of \$7.25 per capita for the year 2024 in the amount of \$588,309.00 and at the rate of \$8.00 per capita for the year 2025 in the amount of \$649,168.00.

Section 2. That the Mayor and/or Director of Public Service are hereby authorized to execute said contract and to take such action and to execute such other documents and amendments thereto as may be necessary as are approved by the Law Director.

Section 3. That there is hereby appropriated the sum of \$588,309.00, Fund No. 001-002-District Health; Account No. 62038-00000-District Health Subsidy, to be deducted by the County Fiscal Officer from the regular tax settlement for the City of Parma for the year 2024 and \$649,168.00 for the year 2025.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason this measure is necessary for the Cuyahoga County General Health District to commence the provision of public health services on January 1, 2024, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
