Section 2. That the Director of Public Service is hereby authorized to execute said Contract and to take such action and to execute such other documents and amendments thereto as may be necessary and as are approved by the Law Director.

Section 3. That funds for said Contract shall be funded from Fund No. 405-405 – Capital Improvements; Account No. 62110-00000 – Professional Services; and Fund No. 192-192 – American Rescue Plan Act; Account No. 67100-00000 – Street Repairs ARPA – Rev. Replacement, under the Northeast Ohio Regional Sewer District and the Cuyahoga County Department of Public Works, through the Member Community Infrastructure Grant Program.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council; and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Parma, and for the further reason that this measure is necessary in order for work to begin at the earliest possible time, and this Ordinance shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
