#### **COMMUNICATIONS. PETITIONS AND CLAIMS**

Mr. Divis - Mr. Chairman, the Planning Committee of Council met on Monday, February 19, 2019, to discuss the Notice of Proposal to Vary for the Applicant Joseph Colini, 5341 Pearl Rd, PPN 443-23-029 & 031.

The request is for a "Variance of the City of Parma Codified Ordinances of Section 1170.03 – COMMERCIAL/OFFICE DISTRICTS – SCHEDULE OF PERMITTED BUILDINGS AND USES." The proposal is to operate a church in an existing building located in retail business district at 5341 Pearl Road. Churches are not included in permitted buildings and uses in Commercial/Office Districts schedule. Churches are only permitted in Single Family Districts. This variance would result in allowing use of building in Retail Business District for a church. Included in this recommendation are the Engineer's comments:

- 1. The Applicant is requesting to operate a church in a Retail Business District. The Council person has been made aware of this Application.
- 2. The Council person would prefer to see a use that creates more economic development. Unfortunately having a church operate in a Retail building does not generate that type of economic development or income that the City needs to have a thriving Retail Business District.
- 3. Granting this "Use" variance would be contrary to what the City and City Council wants and for that reason the Engineering Department recommends denying the variance application.

The Board of Zoning Appeals recommended to grant the variance, however the Planning Committee of Council chose to over-ride their recommendation.
