Councilman Kish – Stated that the temporary appropriation isn't the perfect mouse trap. When you are waiting on information critical to the budget process from income taxes, the County, the State, Health Insurance, Worker's Compensation, to attempt to put together a permanent appropriation prior to the first of the year, he feels would result in nothing but amending appropriations perpetually and continuously throughout the year, and now that Council only meets twice a month, you would be constantly amending appropriations, transferring appropriations, but I think some aspects on what they try to do in way of services, would be put on hold because of that time delay. It is not as simple as it looks.

Councilman Crossman – Stated he has been advocating for a better model of budgeting. They had a conversation about priorities for next year. We are presented with a pretty sizable expenditure for the first three months of next year without any discussion whatsoever about what Council priorities are. Whatever the discussion is going forward about how to budget, feels it has to incorporate some discussion in advance of making these temporary appropriations. Between what we have been doing and what he has suggested which is putting forward a permanent appropriation for the upcoming year, there has to be some better way of doing it that reflects what Council priorities are. Looks forward to future discussions on how they can extract the most efficiencies out of our limited dollars.
