(c) Parking of Commercial Vehicles, (2) Only one commercial vehicle not exceeding a gross weight of 8,500 pounds or an overall height of 82 inches may be parked per dwelling unit. Such vehicles must be parked either in an enclosed garage or on a hard-surfaced driveway or turnabout to the rear of the front setback line of the residence.

The proposal is to park a 96" tall, 8850 lb. delivery van forward of the front setback in a residential driveway, daily.

** The variance would result in allowing a delivery van that is 14" taller and 50 lbs. heavier than code allows **

The second request is a variance to Section 1153.03(f)(8) – ACCESSORY USES AND BUILDINGS – HOME OCCUPATIONS. – Gainful home occupations may be permitted in residential districts, including dressmaking, interior decorating, arts and crafts or any other similar home occupations, but excluding uses permitted as commercial or industrial uses, and may be conducted in the dwelling used by such person as his or her residence, provided that the use does not require the storage of any equipment, materials, or vehicles outside the main building.

The proposal is to park a vehicle outside of a residence for transporting food and snacks for a vending business.

** The variance would result in allowing a business vehicle to be parked and stored in a residential district. **

The recommendation is to grant the variance with the stipulations that the van not have commercial plates and no advertisements be on the van. Michelle Green seconded the motion. George Mastrobuono and Allesan Armstrong all agreed.

After discussion George Ziefle recommended to Council to grant to Jeffrey R. Dvorak of 9914 Vienna Drive an "Area" variance with stipulations of the City of Parma Codified Ordinance Section 1153.03(b)(6) SINGLE FAMILY HOUSE DISTRICTS – ACCESSORY USES & BUILDING-

REGULATIONS – PARKING AREAS – for a residential lot with a front setback of 30 feet or more, a parking pad is not permitted within 5 feet of the right-of-way line nor in the interior of the lot.

The proposal is to construct a driveway with parking pad, 20 feet wide at the public sidewalk, widening to 25.5 feet wide at the house, with a parking pad to the exterior of the lot.

** The variance would result in allowing a parking pad to be constructed closer to the right-of-way than code allows. **

The recommendation is to grant the variance stipulating that the parking pad be set 3 feet from the public sidewalk and shrubbery be installed in the space adjacent to the public sidewalk. Allesan Armstrong seconded the motion. George Mastrobuono and Michelle Green all agreed.

After discussion Allesan Armstrong recommended to Council to grant to Harry & Connie Azzano of 7902 Newport Avenue an "Area" variance of the City of Parma Codified Ordinance Section 1189.08(d) FRONT YARD LINE EXCEPTIONS – Entrance canopies or similar overhanging roofed spaces covering not more than 20 square feet of horizontal area for each 40 feet of lot frontage, porticos or bays projecting not more than 3 feet, exclusive of cornices, and aggregating a vertical area in any story of not more than 20% of the area of the face of that story, are exempt from the front or side street yard restrictions of this Zoning Code on buildings not nearer the street line than 10 feet.

Proposal is to construct a covered front porch that projects 8 feet with a vertical area of 85% of the story.

** The variance would result in allowing a covered porch to project an additional 5 feet and 65% more of the vertical area than code allows. **

George Ziefle seconded the motion. George Mastrobuono and Michelle Green all agreed.

After discussion George Ziefle recommended to Council to grant to Chiuchiarelli Builders for 7705 E. Linden Lane an "Area" variance with stipulations of the City of Parma Codified Ordinance Section 1153.03(a) – SINGLE FAMILY HOUSE DISTRICTS – ACCESSORY USES AND BUILDINGS. Not more than one garage, whether attached or detached, shall be permitted on any one lot. The maximum size garage allowed on a lot shall not exceed a total floor area of 800 square feet.

The proposal is to erect a 4-car garage of 1300 square feet on lot size of 74,295 square feet.

** This variance would result in allowing a garage 500 more square feet in garage area than allowed by code. **

The recommendation is to grant the variance stipulating that no shed or outbuildings be constructed, and the garage doors shall be carriage style or equivalent. Michelle Green seconded the motion. George Mastrobuono and Allesan Armstrong all agreed.
