COMMUNICATIONS, PETITIONS AND CLAIMS

Councilman Divis - Stated the Planning Committee of Council met to discuss the Notice of Proposal to Vary for the Applicant Mr. Brett Iafigliola, P.E., 5280 Broadview Road on Permanent Parcel Number 445-03-033. The proposal is for constructing a hunger center addition. The Request is for an Area Variance of Section 1197.11 (a) — OFF STREET PARKING AND LOADING FACILITIES — LOADING AND UNLOADING FACILITIES — LOCATION OF LOADING SPACES. All required loading spaces shall be located on same lot as the use served and arranged so public street or sidewalk will not be occupied during loading or unloading. Spaces shall not be located in any required yard or less than 50' from residential district. The request is for loading area in a required yard. This variance will result in allow for loading area in required yard. An additional Request is for an "Area" variance of the City of Parma Codified Ordinances of Section 1153.05 © (1)-SINGLE FAMILY HOUSE DISTRICTS — PUBLIC FACILITIES. The maximum lot coverage by all main and accessory building shall not exceed 25% of the lot. The proposed lot coverage is 29.4%. This variance would result in 4.4% additional lot coverage.

Motion made by Councilman Divis seconded by Councilman Day to grant the above Variances as recommended by the Parma Board of Zoning Appeals and the Planning Committee of Council. Motion carried.

Councilman Divis - Stated Planning Committee of Council met to discuss the Notice of Proposal to Vary for the Applicant Mr. David Nawrocki, 9720 Tracy Trail on Permanent Parcel Number 456-13-003. The proposal is for a new detached garage. The Request is for an Area Variance of Section 1153.03 (a) – Single Family House Districts – Accessory Uses and Buildings. Maximum size of garage permitted on lot size of $60' \times 150'$ (9,000 sq. ft.) lot area is 800 sq. ft. with maximum height of 15 feet. The proposed new detached garage to be built at 9720 Tracy Trail is $24' \times 40'$ (960 sq. ft.) area with a height of 15'6'' on parcel of 9,000 sq. ft. This variance would result in allowing 160 more sq. ft. in area and 6'' more in height than Code allows for detached garage on lot size of 9,000 sq. ft. in area.
