AN ORDINANCE TO AMEND THE 2020 PERMANENT APPROPRIATIONS OF THE CITY OF PARMA, OHIO, AND DECLARING AN EMERGENCY

Councilwoman Lime - Asked for an explanation.

Auditor Day – Stated there is a column for debits and a column for credits. The Debits are increasing the appropriations. The first three line items are Court related for indigent alcohol treatment program, court facility management fee and clerk computerization. All the funds are available, they just need to appropriate more. The line item for Fund 455, \$579,325, is the 2020 Catch Basin Repair Program. It is County reimbursement, but they set up a separate fund in order to track it. The line item for Assistant Pool Manager is from when the appropriations were reduced because they were not opening the pools. It was requested to re-appropriate because the splash pads will open.
