Councilwoman Lime asked for explanation from Interim Director on where the \$110.24 shortfall came in.

Interim Director Pointer-Hicks stated that when she came into the position a few months ago and audited the petty cash fund it was \$110.24 short. She looked for it and for receipts and asked staff if anyone knew if there were any additional receipts. She stated she has known about this for awhile and continued to look for the money and get back to the \$400 that it should have been. It was just time for it to just be written off.

Councilwoman Lime asked what the procedure is for using petty cash within Public Housing.

Interim Director Pointer-Hicks said that she can tell her what she was told and since she has been there she has used petty cash only once. Purchased envelopes for posters that we are using for the lottery that is opening tomorrow. Otherwise, she has not used petty cash for anything but the petty cash box had supposedly \$200 for each of the programs (Voucher and Public Housing) for emergencies (keys, last minute postage, etc.) Beyond that, she really does not know why they needed that amount of money. She agrees there should be some in petty cash in case of an emergency but not the amount of \$400.

Councilwoman Lime asked what safeguards the Interim Director has put in place to make sure there are not shortages in the future.

Interim Director Pointer-Hicks said that the petty cash box is in a safe in her office. She never leaves her office unattended with the door open. The safe is locked at night. No one has access to it.

Councilwoman Lime asked who in the office can use petty cash and if receipts are required.

Interim Director Pointer-Hicks said that no one is allowed to use petty cash unless they ask for her permission, and she would question why they would need to use it.

Councilwoman Lime asked the Interim Director for an explanation of what un-cashed checks meant.

Interim Director Pointer-Hicks said these are checks that have never cleared the bank; Fiscal or Calendar 2014 through December 2014. At least two of the checks never left the building, but they were in the finance records that they had actually issued the checks. We have checked with all the banks and bank statements. These are outstanding. This money was encumbered the moment it was on our books and so now we are putting the money back in our account.

Councilwoman Lime wanted a better understanding of the outstanding checks. Were these checks

from participants that never cleared?

Interim Director Pointer-Hicks said these are for all three bank accounts. The Public Housing Operating Account, Housing Choice Voucher Operations Account and the Housing Choice Voucher HAP Account. This total is for all three accounts. Every month the Finance Department for the City also reconciles the bank accounts along with our Fee Accountant, and they give her a list of checks that are outstanding as well. So utilizing both of those lists is what she uses to determine the amount that is to be written off. The Huntington account which is for Operations - the total was \$3,281.33. In the Public Housing Account for Operations the total was \$2,130.99. And in the Housing Choice Voucher HAP Account the total was \$983.00

Councilwoman Lime asked if these were from people who wrote PPHA checks that never cleared. Interim Director cleared up that these were checks that PPHA wrote to pay their bills along with the HAP Accounts.

Councilwoman Lime asked why these checks would not have cleared.

Interim Director stated she does not know why these checks have not cleared.

Councilwoman Lime asked for an explanation of this Resolution and just doing away with these

checks. What happens to these bills. Have they been paid?

Interim Director said she hopes that if a vendor that we owed money to has not collected from us in six months that we do not owe them. I do not know this for sure. At least one of these transactions while the books show that a check was written, we actually used the debit card to pay this bill online. I do not know this for a fact, that maybe the check got mailed and got lost and then we got behind and then whoever that vendor was...was going to cut off whatever our service was for that period of time. So the debit card was used.

Councilwoman Lime thanked the Interim Director for being very diligent and looking through everything that you have been looking through. You have done an outstanding job. The other thing that I would like to know is, shouldn't the Auditor's for Parma Public Housing, the monthly Auditor's, have caught this stuff?

Interim Director said she is hesitant to answer this question. She is still trying to figure some of this out herself. She would like to say that it should have been seen. She cannot say who should have seen it.

Council President said the important thing is that it has been seen and being addressed.

Interim Director concurred.

Council President echoes Councilwoman Lime's comments and that he appreciates the Interim Director not leaving any money on the table and lifting up all these stones and shedding light on all these issues.

Councilwoman Lime said this just re-emphasizes to Mr. Dipierro why she is looking to have those Auditor's brought in to a Parma Public Housing Meeting. What was the last year and the year before deficit-wise? How much other stuff is out there that is going to show up? Again, I ask you to please schedule the Auditor's to come in so we may question them on these types of things.
