Mr. Brennan - At this point it is up to Council to either vote on the OPBA Fact-Finding Report or remove it from the calendar.

Councilwoman Lime - We can do nothing on this or vote to reject the report. Personally she would like to vote to reject it.

Mayor DeGeeter - We have seven days from the date of issuance to vote on the report and today is the seventh day. It was learned earlier today that the Union did vote to reject. If one party votes to reject it is deemed rejected. It would have been, the Administrations recommendation that we would have rejected the fact-finding report.

Assistant Law Director Miller - The Mayor is absolutely right and Council can proceed. It will be rejected because of the Union vote, however, City Council may also as a gesture reject the report. You can go forward with the vote or not. It is discretionary with the Council.

Mr. Brennan - The Union has spoken on it and why bother voting on it. It is a mute point.

Councilman Divis - I understand we do not have to vote on it because it has been rejected by the Union, but this may be a show of support from Council that we are against it also.

Councilman Tuma - I understand my colleagues comments, but there is no real legal efficacy and I think we just follow the recommendation of our legal counsel and let the rejection from the Union speak for itself.

Councilman Day - We can vote on it or not, but legal recommended that we do not need to do that. We can vote whether or not that we should vote.

Mr. Brennan - We need some kind of a vote. Either to amend the calendar and remove the item, or to take a voice vote on the report.

Councilwoman Lime - Asked about the Comm. Ctr. expenses that came out of the general fund. Why are those two purchases made out of the general fund versus the 423 Communication Account? (Fidelity Voice Service and the 5/3 expenses)

Safety Director O'Malley - This was due to the fact that the Auditor has liquidated that account. There was a mixup with the PO's. Invoices were sitting up in Auditing.

Councilwoman Lime - Asked why it was paid out of General Fund and not the Comm. Center fund. Safety Director O'Malley - Account was scrubbed that was supposed to pay this bill.

Councilwoman Lime - Is 5/3 a legitimate company for the wall mounts?

Safety Director O'Malley - Used the credit card to pay the vendors who were putting up wall mounts at that time. Contractors were on site and needed to be paid at that time.
