Councilman Kussmaul – Thanked Councilman Tuma for working to secure these funds for the city. The ARPA Funds are intended for infrastructure projects and at this time I cannot support this as an infrastructure project.

Mr. Brennan – Thanked Councilman Tuma. We elect our county leaders, our state leaders and our federal leaders to go to Washington to go to Columbus and go to Cleveland to bring home the bacon for our communities. We pay taxes to the County, State and Federal government and who better to know how to spend some of those dollars than the cities themselves at the local level. Commended Councilman Tuma for all his hard and diligence. This is a project that has been talked about ever since he joined Council almost 19 years ago. He has a tough job. There are many projects and many people vying for our county dollars, and he personally thanks him on behalf of the city for his hard work.

Mayor DeGeeter – Stated when Councilman Tuma knew he would have these funds, he scheduled a meeting. He had Auditor Day, Treasurer Mastroianni, Law Director Dobeck, then Service Director Higgins, current Service Director Vannello, Rich Summers and Councilman Tuma said we would have to apply for the funds. It was pretty unanimous in that room when he asked what project we would like to work on. Everybody in that room all pointed towards the Event Center. It was a collaborate approach, we applied, and we are grateful for receiving the \$4 million.

Clerk of Council Ramser – Stated he served on Council with Councilman Tuma, and he was here when he left to go to the County. Commended Councilman Tuma. He is doing a great job. He also questioned the funds. He was told the funds were coming out of the general fund. He understands what Councilman Kussmaul is saying, but he was told the funds were coming out of the general fund.

Councilman Kussmaul – Stated he is not disputing the use of the funds or receiving them through the lost revenue bucket with the county so we can use them as we wish. He is only saying, in the spirit of the ARPA when it was passed, it was for infrastructure projects.
