Mr. Dipierro – Stated, you have before you the minutes from the Regular Council Meeting of February 6, 2023. Asked if there were any additions or corrections to the minutes? Stated, hearing none, the minutes will stand as printed.

#### COMMUNICATIONS, PETITIONS AND CLAIMS

Mrs. Saban – Read a letter from Lisa M. Williams/Manager Government Relations U.S Post Office.

Councilwoman Lime – Asked for an update as far as the property owner of the Post Office. Stated that the front door has been broken for over three months and that there is a broken lamp sitting along side of the building. Councilwoman Lime stated she passed by the Day Drive site one evening and noticed the flag was not lit. She also stated that she finds the whole situation an embarrassment.

Mayor DeGeeter – Asked Building Commissioner Kulchytsky to come up, but stated that an inspection was done, and there were violations. He also stated that Congressman Max Miller is involved.

Building Commissioner Kulchytsky – Stated that after the last meeting they did send out Property Maintenance Inspectors to both the State Rd. site and the Day Dr. site. He stated that there were no violations from State Rd. but Day Dr. did have a list of violations. The violations were reviewed by the Manager on site. Mr. Kulchytsky stated that he contacted the property owner who is out of state, that the property on Day Dr. was leased to the U.S. Postal Service. He stated that he was unsure of the results of that meeting with the inspectors. Mr. Kulchytsky also stated that Jim Lobenthal of our Property Maintenance Department also had a meeting set up with the owner from New York to review the site on Day Dr., but did not have any information on what resulted from that meeting, but will follow up with Council members in the near future.

Councilwoman Lime – Asked if there was an NOV written? Building Commissioner Kulchytsky – Replied with a yes. Councilwoman Lime – Asked about the compliance date? Building Commissioner Kulchytsky – Stated that he did not have the date handy. Councilwoman Lime – Asked if Commissioner Kulchytsky would please let her know.

PPN445-01-036. After discussion Michelle Green made the following recommendations: I make a motion to recommend to Council to deny Ubiguitous Design, LTD for Brickrealty, LLC of 2221 Brookpark Rd. Parma, Ohio 44134 has requested variances of the City of Parma Codified Ordinances of Section 1197.05 (27) OFF STREET PARKING AND LOADING FACILITIES SCHEDULE OF REQUIRED PARKING – EATING PLACES, BARS AND TAVERNS. One space per 50 square feet of public floor area is required. This building has 2,350 square feet of public area requiring 37 parking spaces. The side has 3 parking spaces. The applicant is requesting a variance for 44 fewer spaces than required by code. Mrs. Alesan Armstrong seconded it. The board members were concerned with the safety of pedestrians. Brickrealty is offering valet parking, but the members were concerned with pedestrian not using and crossing Brookpark Road on their own. Mr. George Mastrobuono, Michele Green and Alesan Armstrong voted not to grant the variance.

For the applicant Mittas Holdings, LLC and DGP Properties. After discussion Mrs. Green made the following recommendations: I make a motion to recommend to Council to deny DLZ Corporation for: Mittas Holdings LLC and DGP Properties, LLC regarding the property at 7889 York Rd. Parma, Ohio 44130 PPN: 456-26-027 has requested variance of the City of Parma Codified Ordinances of Section 1170.08 – SCHEDULE OF YARD HEIGHT REFULATIONS. The proposal building is in the Retail Business District is required by code to have a front building setback of 30 feet. The building is proposed at a 5-foot front setback. The Applicant has requested approval for 25 feet less front building setback that requires. Mrs. Alesan Armstrong

seconded it. Mr. George Mastrobuono, Mrs. Michele Green, and Mrs. Alesan Armstrong voted not to grant variance.

Councilwoman Shuman – Stated that this is in her ward, it is the property between German Central and the gas station, where the creek runs through. She said that the owner of the parcel lives out of town, and that they have been trying to get something on this property. She stated that if the land is touched, it would affect all five of the sewer projects that are happening now. Councilwoman Shuman stated that she hopes that the variance would not be considered and also stated that West Creek had also been trying to buy this property but DLZ would not sell it, and that she could not imagine anything fitting on the property.

Mayor DeGeeter - Stated that this is the second time that someone wanted to develop this property. He also stated that DLZ is the engineer who has done the design work. The Mayor added that besides the Administration, the Sewer District and West Creek being against this, Cleveland Soil and Water are now involved. The Mayor stated that he hopes that Council would unanimously reject the request for this variance.

Motion made by Councilman Euerle seconded by Councilman Casselberry to thereafter read the variance application by title only and further moved to refer the variance to the Planning Committee. Motion carried.
