Mr. Brennan – Stated, you have before you the Minutes from the Regular Council Meeting held on Monday, September 4, 2018. Asked if there were any additions or corrections? Stated, hearing none, the Minutes will stand approved as printed.

COMMUNICATIONS, PETITIONS AND CLAIMS

Motion made by Councilwoman Lime seconded by Councilman Napoli to authorize the Law Department to file and Prosecute a nuisance action in Cuyahoga County Court of Common Pleas against the owners of the property located at 7516 Dresden Avenue in the City of Parma, Ohio. Motion carried.

Councilwoman Lime – Stated that Council has passed two nuisance resolutions against the property. The family came to Council Meetings and they have sent letters. They have also sued the City. This issue has been going on for over 20 years. There are no utilities, the back porch is gone, it is in extreme disrepair. Unfortunately, the family refuses to sell it and they refuse to make repairs. In order to move forward and demolish the house, it has been brought forward by the Law Department. Asked, on behalf of the neighbors, for Council's support to proceed.

Mr. Brennan – Stated that it is sad that it had to come to this, because they have had so many opportunities to remedy the situation.

Councilwoman Lime – The property owner has been in Housing Court several times and he has also been put in jail for the violations, and that was 15 years ago.

Law Director Dobeck – Stated that our Community Development Director Erik Tollerup was ready to go on this and he appreciates his hard work. Feels a judicial decree is the way to go about this. There are some people that the criminal aspects, the jail time, the citations just don't work on. So, they are hoping to get a judicial decree from the Common Pleas Court to resolve this once and for all for the residents.

Mr. Brennan – Feels it is the best way. Anytime you are going to seize someone's property, it is a good idea to have those checks and balances.

Councilman Crossman – Asked who bears the costs associated with the efforts? Is it the tax payers, or can we recover some costs through this process?

Mr. Dobeck – Stated he can't say whether any of the costs have been placed on the tax duplicate or not. They have been in criminal court prior to this, and in the criminal court, they will require restitution or they will require compliance or they will require a penalty/sanction. He cannot tell him where that is at this point. Doesn't think there have been any costs that have been placed on the tax duplicate at this point. Going forward with the law suit, they are keeping track of every cost that they incur for this point forward.

Councilman Crossman – Stated they hate to see houses torn down or even move in that direction. Their primary focus is on compliance and making sure that everyone lives in a nice neighborhood. When push comes to shove, you have to protect the neighborhood

Councilwoman Lime – Stated when the property owner is at the house, he cuts the grass with a sickle. The City's grass cutter has also been there.

The Parma Board of Zoning Appeals met on Tuesday, Sept. 11, 2018 and PROPOSED TO "VARY, subject to the provisions of amended Ordinance 1127 .13 (confirmation or rejection by Council within forty days of the receipt of this notice) FOR THE APPLICANT Richard Carr, Emerald Development & Economic Network, Inc., 7812 Madison Ave., Cleveland, OH 44102 for property at 7022 State Rd. PPN 450-26-005. After discussion Mr. Ziefle made the following recommendation: "I make a motion to recommend to Parma City Council to grant Richard Carr of Emerald Development & Economic Network, Inc., 7812 Madison Avenue, Cleveland, OH 44102 has requested a "Use" Variance of the City of Parma Codified Ordinances of Section 1153.02 - SINGLE FAMILY HOUSE DISTRICTS PRINCIPAL USES AND BUILDINGS. The proposal is to be classified as a multifamily 4-family apartment dwelling in a singlefamily house district for property located at 7022 State Road. Within any single-Family House District, no building or premises shall be erected, used, arranged or designed to be used in whole or in part, for other than single-family detached dwellings. This variance would result in allowing for four suite apartment building in a Single-Family House District. The PPN is 450-26-005. By not granting this variance the owner's property would suffer a substantial detriment. By granting this variance the characteristic of the neighborhood would not be substantially altered and by granting the variance the spirit and intent of the Zoning/Building requirements would be observed." Mrs. Kraft seconded the motion. Mr. Ziefle, Mrs. Kraft, Mr. Mastrobuono and Mr. O'Connor voted yes. Also be it noted that a variance(s) once granted, shall not be withdrawn or changed unless there is a change of circumstances or if after the expiration of six months no substantial construction is done in accordance with the terms and condition for which such variance was granted. In which case the Building Commissioner shall give notice in writing, and thirty days thereafter the variances will be deemed null and void, and all regulations governing such premises in question shall revert back to those in effect before the variance was granted.

Mr. Brennan – Said Variance will be referred to the Planning Committee.
