Two variances were denied by the Parma Board of Zoning Appeals for the applicant James Wise (HW Property Group- Holton Wise) PPN 443-29-036 (Zoned Retail Business) and PPN 443-29-118 (Zoned Single-Family B-1).

The first request was for a "Use variance" of PCO 1153.02 - Single Family House District. The request is to use single-family use property for a storage facility which is only permitted in Commercial Manufacturing "B". This property is located at 5296 State Road.

The second request was a "Use variance" of PCO 1170.03(H)(3) - Commercial/Office Districts - Schedule of Permitted Buildings and Uses. The request is to use property in Retail Business District for a storage facility establishment which is permitted only in Commercial Manufacturing "B" Zoning District.

Mr. Brennan referred this to the Planning Committee of Council.

A "Use" variance of PCO 1153.02 - Single Family House Districts - Principal Uses and Buildings was granted by the Parma Board of Zoning Appeals for the applicant James E. Vorndra, 7584 Ryan Rd., Medina, Ohio, for the property at 5002 Yorkshire Road, PPN 447-07-143. The proposal is to rebuild a current legal non-conforming two-family structure in a Single-Family District should the dwelling have a catastrophic loss in the future. They suggested to take the letter from Council approving this variance to the County Recorder Office and have letter recorded with the deed so if the house is sold, the new owner will not have to go through this process again.
